# **Qualico Communities Experience Cochrane Contest Rules**

QUALICO COMMUNITIES' CONTEST (THE "CONTEST") IS INTENDED TO BE CONDUCTED IN THE PROVINCE OF ALBERTA ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF ALBERTA OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

# **ELIGIBILITY**

- To be eligible for this Contest, an individual must:
- be a legal resident of the province of Alberta; and
- be of the age of majority in the Province of Alberta or older at the time of entry.
- not have won any previous Qualico Community prize.

Employees of Qualico Communities (sometimes referred to herein as the "Sponsor") and respective affiliates, subsidiaries, related companies, advertising and promotional agencies, and the household members of any of the above, are not eligible to participate in the Contest.

The Sponsor shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsor for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsor reserves the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate, or misleading personal details and/or information.

## **CONTEST PERIOD**

The Contest begins at midnight Mountain Daylight Time ("MDT") on March 1, 2024 and ends at midnight MDT on May 3, 2024 (the "Contest Period") after which time the Contest will be closed and no further entries shall be accepted.

# **HOW TO ENTER**

- (a) There is no purchase necessary to enter the Contest. To enter, visit one or all of the showhomes in Rivercrest (Janssen Homes, Trico Homes, Sterling Homes, and Broadview Homes) and fill out a physical ballot or enter the draw via electronic scan code Google form. ONE entry per person will be accepted. An entrant CANNOT submit both a paper form and an electronic scan code Google form. No entries will be accepted by any other means.
- (b) Limit of one (1) entry per person during the Contest Period. In the case of multiple entries, only the first eligible entry will be considered.
- (c) All entries become the sole property of the Sponsor and none will be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, incomplete, forged, illegible, or electronically reproduced.
- (d) Proof of identification will be required by the prize winner prior to the Prize disbursement.

## **PRIZE**

- There is one (1) prize (the "Prize") available to be won by the Prize winner (the "Winner") consisting of Experience Cochrane excursions valued at approximately \$2,000.00.
- Prize has an approximate value of two thousand Canadian dollars (CDN \$2,000.00) but cannot be redeemed for cash.
- Once the Winner has been successfully contacted and notified of his/her Prize and fulfilled the requirements set out herein, Sponsor will contact the Winner to coordinate the Prize pick up details and an estimated timeline of when the Prize will be available for pick up. Once available, the Prize will be available for pick-up by the Winner at Qualico Communities located at #200, 37 Quarry Park Blvd. SE Calgary, AB T2C 5H9.
- Prize must be accepted as awarded and cannot be transferred, or assigned, except at the sole discretion of the Sponsor.
- The Sponsor shall not assume any liability if the Prize is lost, damaged, or misdirected.

## WINNER SELECTION

One (1) Winner shall be selected as follows:

- On or about May 3, 2024, in Calgary, Alberta one (1) entrant will be selected by a random draw from all eligible entries received during the Contest Period. The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsor. Before being declared a Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail, to comply with the Contest Rules and sign and return the Release (described below).
- THE SELECTED ENTRANT WILL BE NOTIFIED BY EMAIL NO LATER THAN May 6, 2024, AT 8 A.M. MDT AND MUST RESPOND WITHIN THREE (3) BUSINESS DAYS OF NOTIFICATION. Upon notification, the selected entrant must respond by telephone to the contact number provided in the notification, and the selected entrant's response must be received by the Sponsor within three (3) business days of such notification. If the selected entrant does not respond in accordance with the Contest Rules, he/she will be disqualified and will not receive the Prize and another entrant may be selected in the Sponsor's sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsor is not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsor to receive a selected entrant's response.
- If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the Prize.

# **RELEASE**

Winner will be required to execute a legal agreement and release ("Release") that confirms Winner's:(i) eligibility for the Contest and compliance with these Contest Rules; (ii) acceptance of the Prize as offered; (iii) release of the Sponsor and its subsidiaries, affiliates and/or related companies and each of their employees, directors, officers, suppliers, agents, sponsors, administrators, licensees, representatives, advertising, media buying and promotional agencies (collectively, the "Releasees") from any and all liability for any loss, harm, damages, cost or expense arising out of participation in the

The executed Release must be returned within three (3) business days of the date indicated on the accompanying letter of notification or the verification as a Winner or the selected entrant will be disqualified and the Prize forfeited.

#### INDEMNIFICATION BY ENTRANT

By entering the Contest, entrant releases and holds Releasees harmless from any and all liability for any injuries, loss or damage of any kind to the entrant or any other person, including personal injury, death, or property damage, resulting in whole or in part, directly or indirectly, from acceptance, possession, use or misuse of the Prize, participation in the Contest, any breach of the Contest Rules, or in any Prize-related activity. The entrant agrees to fully indemnify Releasees from any and all claims by third parties relating to the Contest, without limitation.

The Sponsor assumes no responsibility or liability for lost, late, falsified, misdirected or incomplete entries, notifications, responses, or replies, or for any computer, online, software, telephone, hardware or technical malfunctions that may occur, including but not limited to malfunctions that may affect the transmission or non-transmission of an entry. The Sponsor is not responsible for any incorrect or inaccurate information, whether caused by website users or by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the administration of the Contest. The Sponsor assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries. The Sponsor is not responsible for any problems, failures or technical malfunction of any telephone network or lines, computer online systems, servers, providers, computer equipment, software, e-mail, players, or browsers, on account of technical problems or traffic congestion on the Internet, at any website, or on account of any combination of the foregoing or otherwise. The Sponsor is not responsible for any injury or damage to entrant or to any computer related to or resulting from participating or downloading materials in this Contest. Entrant assumes liability for injuries caused or claimed to be caused by participating in the Contest, or by the acceptance, possession, use of, or failure to receive the Prize. The Sponsor assumes no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including those reasons beyond the control of the Sponsor, such as infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest, and/or the Contest Website.

### **CONDUCT**

By participating in the Contest, each entrant agrees to be bound by the Contest Rules, which will be posted at the Contest Website and made available throughout the Contest Period. Entrant further agrees to be bound by the decisions of the Sponsor, which shall be final and binding in all respects. The Sponsor reserves the right, in their sole discretion, to disqualify any entrant found to be:

(a) violating the Contest Rules; (b) tampering or attempting to tamper with the entry process or the operation of the Contest and/or the Contest Website; (c) violating the terms of service, conditions of use and/or general rules or guidelines of any Qualico property or service; and/or (d) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person.

# PRIVACY / USE OF PERSONAL INFORMATION

- (a) By participating in the Contest, entrant: (i) grants to the Sponsor the right to use his/her name, mailing address, telephone number, and e-mail address ("Personal Information") for the purpose of administering the Contest, including but not limited to contacting and announcing the Winner; (ii) grants to the Sponsor the right to use his/her Personal Information for publicity and promotional purposes relating to the Contest, in any and all media now known or hereafter devised, without further compensation unless prohibited by law; and (iii) acknowledges that the Sponsor may disclose his/her Personal Information to third-party agents and service providers of any of the Sponsor in connection with any of the activities listed in (i) and (ii) above. The Personal Information as it relates to the Contest will be destroyed within one (1) year after the termination of the Contest.
- (b) If the entrant so selects on the Contest entry form to receive information related to any other Qualico community or to receive any other newsletter or join a similar email or mailing list, the entrant then consents to granting the Sponsor the right to use the Personal Information for the purpose of providing such information or including the entrant in such aforementioned email(s) or mailing list(s) in addition to for the Contest. The Personal Information relating to the items in this paragraph (b) will be retained for the purposes thereof notwithstanding the termination of other Personal Information in paragraph (a) above. (c) Qualico Communities will use the entrant's Personal Information only for identified purposes, and protect the entrant's Personal Information in a manner that is consistent with Qualico's Privacy Policy at: qualico.com

All rights are reserved. Unauthorized copying or use of any copyrighted material or intellectual property without the express written consent of its owner is strictly prohibited.

# **TERMINATION**

Sponsor reserves the right, in their sole discretion, to terminate the Contest, in whole or in part, and/or modify, amend or suspend the Contest, and/or the Contest Rules in any way, at any time, for any reason without prior notice.

LAW

These are the official Contest Rules. The Contest is subject to applicable federal, provincial, and municipal laws and regulations. The Contest Rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over the Sponsor. All issues and questions concerning the construction, validity, interpretation and enforceability of the Contest Rules or the rights and obligations as between the entrant and the Sponsor in connection with the Contest shall be governed by and construed in accordance with the laws of the province of Alberta including procedural provisions without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws.

# LANGUAGE DISCREPANCY

In the event of any discrepancy or inconsistency between the terms and conditions of the Contest Rules and disclosures or other statements contained in any Contest-related materials, including but not limited to the Contest entry form, or point of sale, television, print or online advertising, the terms and conditions of the Contest Rules shall prevail, govern and control.
